## Scholarships and TFW scheme:

- 1. Smt Leela Nath Memorial scholarship: All female candidates who are admitted to any of the PGDM programs at IMT Ghaziabad will receive a scholarship of 25% on the academic fees component. Please note that the scholarship is disbursed post the candidate joins the campus and pays the required amount of fees and all other components of the fee as mentioned above.
- 2. TFW waiver scheme: Candidates eligible and shortlisted for the Tuition Fee Waiver (TFW) scheme will not be required to pay the academic fee component as they will get a 100% waiver from the same. They will, however, pay all other components of fees mentioned above. In addition to this, they will be required to pay an amount of Rs 19,000/- per month (in advance) towards charges for amenities and other facilities in Foundation, Term 1, and Term 6. Additionally, they will pay the hostel fees for IMT Dubai as per the above fee structure (single or double occupancy). They will pay other components of fees apart from tuition fees at IMT Dubai.

Please note in case a student is eligible under more than one scholarship(s) and/or fee waiver scheme, he/she will have to opt for one of such eligible scholarships/waiver schemes, and such opted scholarship/waiver scheme will only continue to remain during the entire tenure of PGDM Program. The decision of the Scholarship Committee is final and binding for final allocations of scholarships/waivers and will not be revised under any circumstances.IMT reserves the right to change the fees, scholarship waivers and any other charges at any point in time before the commencement of the Academic year (2024).
